In view of above, I am directed to inform you that this is provisional affiliation to your college and as such you are requested to comply with the above mentioned deficiencies within the stipulated time without fail and submit compliance report. Compliance report will be verified by the University by re-inspection of your college.

Important Note:

- 1) This Continuation / Extension of affiliation is issued for the A.Y. 2022-2023 subject to the permission of NCISM / Govt. of India / Department of AYUSH, New Delhi and if the permission is declined by the said authorities, this Continuation / Extension of Affiliation will be treated as cancelled. The College is not authorized to admit the students for 1st Year of the course until receipt of permission of the NCISM / Govt. of India/ Department of AYUSH New Delhi.
2) The admission shall be done through the Competent Authorities only.
