Candidates who have appeared for AIAPGET-2025 examination and desirous of applying for available seats of Ayurved/ Homoeopathy/ Unani Course in State Government/Private Aided/ Unaided Private and Minority Colleges situated in the State of Maharashtra, should Registered Online on website i.e. **www.mahacet.org**.

### **Instructions for Candidates – Online Registration (PG AYUSH)**

#### **1. Information Brochure -**

The detailed Information Brochure for PG AYUSH is available on the State CET Cell website i.e. [www.mahacet.org](http://www.mahacet.org). Candidates are advised to read the brochure carefully before proceeding with registration.

#### **2. Eligibility -**

Candidates must ensure that they fulfill the eligibility criteria as mentioned in the Information Brochure before filling the online registration form.

#### **3. PwD Candidates -**

PwD candidates must have claimed their quota at the time of AIAPGET - 2025.

They are required to submit an online PwD certificate issued by any one of the 16 designated Medical Boards.

Certificate issued by any other Board/Civil surgeon will NOT be accepted.

#### **4. Reservation Category -**

Candidates belonging to a reserved category must claim their category status in the online application form before submitting it.

Any request for conversion from Open/General category to Reserved category after submission of form will not be entertained.

#### **5. CVC Submission –**

##### **A) SEBC & OBC Candidates -**

As per Government Resolution No.संकीर्ण २०२५/प्र.क्र.६८/आरक्षण-५, dated 26/08/2025, SEBC and OBC candidates have been granted a 6 months extension for submitting the Caste Validity Certificate (CVC).

Candidates must upload the receipt of application for obtaining the CVC at the time of registration.

**B) SC, VJ, NT, OBC & SBC Candidates -**

As per Government Corrigendum No. क्र.सीबीसी २०२५/प्र.क्र.१३१/मावक, dated 05/09/2025, candidates belonging to SC, VJ, NT, OBC, and SEBC categories are also granted a 6 months extension for CVC submission.

Candidates must upload the receipt of application for obtaining the CVC at the time of registration.

**7. EWS Candidates -**

As per G.R. of General Administration Department ROD-4019/C.R 31/ 16- A, dated 12 February 2019 and Government Resolution no. MED-1018/C.R 37/19/Edu- 2, dated 07th March, 2019. “EWS” means Economically Weaker Section, include persons who are not covered under the scheme of reservation for SC, ST, DT-A, NT-B, NT-C, NT-D, OBC (Including SBC) & SEBC.

**8. Internship Completion -**

The candidate should have completed compulsory rotatory internship on or before 31st July, 2025 for Ayurved and Unani courses and on or before 31st August, 2025 for Homoeopathy course.

**9. Security Deposit -**

The security deposit will be forfeited / refunded as per the provision in Table-2 of the information brochure (page no.) The security deposit will be refunded to eligible candidates to their source account hence candidate should ensure that the account from which security deposit is paid is kept active till refund is process.
